Founded in 2010, the OpenADR Alliance includes more than 60 utilities and controls vendors who have already announced or deployed OpenADR-based systems across the United States and the globe.

## So what is OpenADR?

The OpenADR Alliance was created to standardize, automate, and simplify DR and DER to enable utilities and aggregators to cost-effectively manage growing energy demand & decentralized energy production, and customers to control their energy future. Together we are creating the future of smart grid modernization today. The OpenADR Alliance is creating a robust ecosystem of certified products for enabling automated demand side management among residential, commercial and industrial customers.

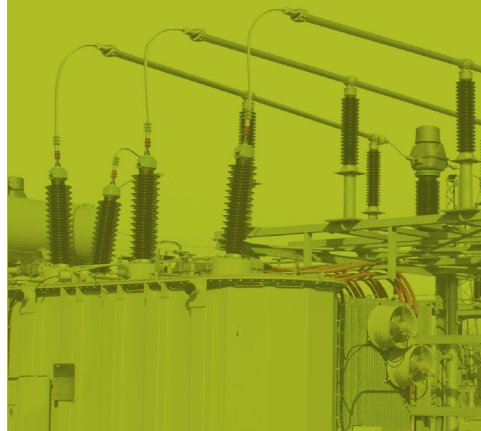
The OpenADR Alliance currently has over 130 members including utilities, software suppliers, device manufacturers, national labs, DR aggregators, testing and certification labs, system integrators, and consulting firms. Members get support from the Alliance's technical and marketing committees to enable shorter development cycles. Members get early access to specifications and have the opportunity to influence the evolution of the OpenADR standard. Members also have the opportunity to certify their products as OpenADR-compliant.

The OpenADR protocol is a standardized way to exchange fast, reliable, and secure price, energy, and control messages to a wide variety of customer installed equipment such as electric vehicle charging stations, general loads and energy management systems.

## OpenADR Membership Options

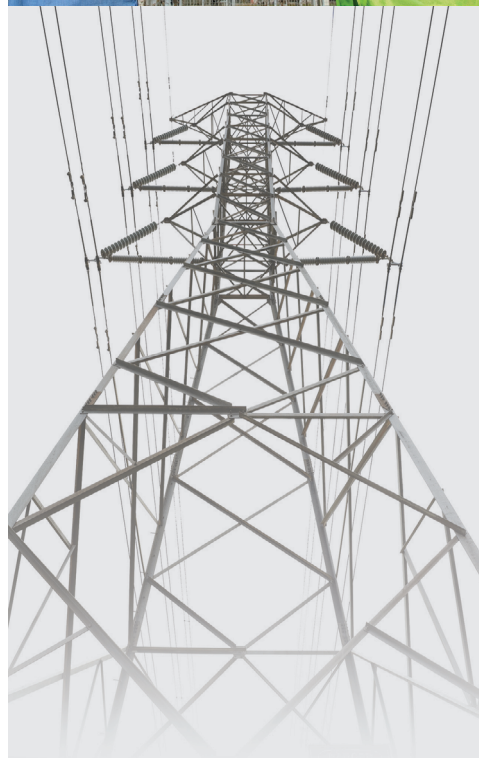
